REACH- and CLP-compliant safety data sheet (SDS)

According to Chapter 1.5.2 of the UN Globally Harmonized System of Classification and Labelling of Chemicals (GHS), Article 58 (2)(a), and Article 59(2)(b) of (EC) No 1272/2008 (CLP), which amends REACH article 31(1), safety data sheets (SDS) are only required for substances and mixtures that meet the harmonised criteria for physical, health or environmental hazards. Consequently, a formal SDS according to (EU) 878/2020 are only issued for hazardous substances but not for non-hazardous substances. In order to communicate relevant HSE-(health, safety and environmental) information for non-hazardous substances, product safety information (PSI) is provided instead.
